**Section A: European history in the interwar years, 1919–41**

- 1 Assess the impact of Mussolini's foreign policy on Italy. [30]
- 2 Evaluate the causes of the Great Terror. [30]
- 3 Assess the aims of Hitler's foreign policy in the period 1933–41. [30]
- 4 'Britain followed a policy of appeasement because it was militarily unprepared for war.' Discuss this view. [30]

**Section B: The USA, 1944–92**

- 5 Assess the reasons for the opposition to the Civil Rights movement in the Southern states in the 1950s. [30]
- 6 'During the 1960s and 1970s it was clear that post-war economic doctrines were failing.' Discuss this view. [30]
- 7 Evaluate the effectiveness of Affirmative Action policies in the 1980s. [30]
- 8 Assess the importance of the Bretton Woods agreement of 1944 for the United States. [30]

**Section C: International history, 1945–92**

- 9** Assess the impact of the Prague Spring on US–Soviet relations. [30]
- 10** ‘It was the failure of the US post-war policy in China which enabled the Chinese Communist Party to gain power in 1949.’ Assess this view. [30]
- 11** Analyse the reasons why the United Nations failed in Somalia. [30]
- 12** Evaluate the role of the United States in the creation of Israel. [30]
