General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor must perform the experiments and record the results as instructed.
 This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
 - the scripts of the candidates specified on the bar code label provided
 - the supervisor's results relevant to these candidates
 - the supervisor's reports relevant to these candidates
 - seating plans for each practical session, referring to each candidate by candidate number
 - the attendance register.

Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do all the experiments and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

If chemicals are prepared in more than one batch, clearly labelled supervisor's results must be provided for each batch. The candidates using each batch must be listed on the supervisor's report.

balance, single-pan, direct reading, minimum accuracy 0.01 g (1 per 8-12 candidates) weighing to 200 g

- 1 × wash bottle
- 1 × pen for labelling glassware

paper towels

red and blue litmus papers

aluminium foil

wooden splints

the apparatus normally used in the centre for use with limewater in testing for carbon dioxide

*Candidates are expected to rinse and reuse test-tubes where possible.

Additional tubes should be available.

Where balance provision is limited, some candidates should be instructed to start the exam with different questions. See the current syllabus for balance: candidate ratio.

The materials listed in the table must be provided to each candidate.

FA 1 [MH][N]	2.0 ± 0.1g	basic copper(II) carbonate	Provide 2.0 ± 0.1 g CuCO ₃ •Cu(OH) ₂ [MH][N] in a stoppered container. Any type of basic copper(II) carbonate is suitable.
FA 2	30 cm³	2.0 mol dm ⁻³ hydrochloric acid	See preparation instructions in the current syllabus.
FA3 [MH]	130 cm³	0.095 mol dm ⁻³ copper(II) sulfate	Dissolve 23.73g [C][MH][N] of CuSO ₄ •5H ₂ O in each dm ³ of solution.
FA 4	150 cm³	0.100 mol dm ⁻³ sodium thiosulfate	Dissolve 24.82g of Na ₂ S ₂ O ₃ •5H ₂ O or 15.82g of Na ₂ S ₂ O ₃ in each dm ³ of solution.
FA 5	75cm³	0.50 moldm ⁻³ potassium iodide	Dissolve $83.0g$ of KI in each dm 3 of solution.
FA 6	10 cm³	starch indicator	See preparation instructions in the current syllabus.
FA7 [MH][N]	19	basic copper(II) carbonate	Provide 1.0 \pm 0.1 g CuCO ₃ •Cu(OH) ₂ [MH][N] in a stoppered container. Any type of basic copper(II) carbonate is suitable. This is the same compound as FA 1 .
FA 8 [MH]	10 cm³	$0.105\mathrm{moldm^{-3}}$ copper(II) sulfate	Dissolve 26.21 g of CuSO ₄ •5H ₂ O [C][MH][N] in each dm ³ of solution. This is the same solution as FA 3 .
M [F]	1	magnesium powder	Provide 1.0 \pm 0.1 g Mg [F] in a stoppered container.
FA 9	10 cm³	0.2 mol dm ⁻³ sodium carbonate	Dissolve 21.2g of Na ₂ CO ₃ [MH] or 57.2g of Na ₂ CO ₃ •10H ₂ O [MH] in each dm³ of solution. Prepare a fresh solution for use in the practical.
FA 10	10 cm³	0.1 mol dm ⁻³ potassium iodide	Dissolve 16.6g of KI in each dm^3 of solution.
Conc. HC1[C][MH]	3 cm³	concentrated hydrochloric acid	Provide 3 cm ³ concentrated hydrochloric acid [C][MH] in a stoppered container.
aqueous EDTA	10 cm³	0.1 mol dm ⁻³ disodium salt of ethylenediamine tetraacetic acid	Dissolve 37.2g of [CH ₂ N(CH ₂ COOH)CH ₂ COONa] ₂ •2H ₂ O [MH] in each dm ³ of solution. This is also supplied as disodium salt of EDTA (ethylenediamine tetraacetic acid) dihydrate.

dilute hydrochloric acid	10 cm³	$2.0\mathrm{moldm^{-3}HC}{\it l}$	
dilute nitric acid [C]	10 cm³	2.0 moldm ⁻³ HNO ₃	
dilute sulfuric acid [MH]	10 cm³	$1.0\mathrm{moldm^{-3}H_2SO_4}$	
aqueous ammonia [C][MH][N]	10 cm³	2.0 moldm ⁻³ NH ₃	See preparation instructions in the current syllabus.
aqueous sodium hydroxide [C]	10 cm³	2.0 mol dm ⁻³ NaOH	If necessary, each of these reagents can be provided as a communal supply for groups of up to 6 candidates.
aqueous barium chloride	10 cm ³	0.1 moldm ⁻³ BaCl ₂	Invigilators must be alert to the risk of contamination and the opportunity for malpractice when using a communal supply.
aqueous barium nitrate		$0.1 \text{mol dm}^{-3} \text{Ba(NO}_3)_2$	-
limewater [MH]	10 cm³	saturated aqueous calcium hydroxide, Ca(OH) ₂	
aqueous silver nitrate	10 cm ³	0.05 moldm ⁻³ AgNO ₃	
acidified aqueous potassium manganate(VII) [MH]	10 cm³	$0.01 \text{moldm}^{-3} \text{KMnO}_4 \text{ in}$ $0.5 \text{moldm}^{-3} \text{H}_2 \text{SO}_4$
