General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
 - the scripts of the candidates specified on the bar code label provided
 - the supervisor's results relevant to these candidates
 - the supervisor's reports relevant to these candidates
 - seating plans for each practical session, referring to each candidate by candidate number
 - the attendance register.

Specific information for this practical exam

The supervisor must be a teacher of Physics or other competent physicist. During the exam, the supervisor (NOT the invigilator) should obtain a sample set of numerical results by following the relevant steps in the question paper. The results should be clearly labelled 'Supervisor's results' and recorded on the supervisor's report or on a spare copy of the question paper.

Organisation of the exam

- The number of sets of apparatus provided for each experiment should be $\frac{1}{2}N$, where N is the number of candidates taking the exam.
- Candidates should not be provided with any additional apparatus beyond that specified in these instructions.
- Candidates should be allowed access to the apparatus for each experiment for one hour only.
- After spending one hour on one experiment, candidates should change over to the other experiment.
- The order in which a candidate attempts the two experiments is immaterial.

Assistance to candidates


- Candidates should be informed that, if they find themselves in real difficulty, they may ask the supervisor for practical assistance, but that the extent of this assistance will be reported to the Examiner, who may not award full credit for the relevant skills.
- Assistance should only be given when it is asked for by a candidate or where apparatus is seen to have developed a fault.
- Assistance should be restricted to enabling candidates to make observations and measurements. Observations and measurements must **not** be made for candidates, and no help should be given with data analysis or evaluation.
- In cases of faulty apparatus that prevent the required measurements being taken, the supervisor should allow extra time to give the candidate a fair opportunity to perform the experiment as if the fault had not been present.
- Any assistance or extra time given to candidates must be recorded in the supervisor's report.

Materials and apparatus for Question 1 (per set of apparatus unless otherwise specified)


- Wooden metre rule with a millimetre scale. See Note 1.
- 40 metal paper clips, each of approximate length 3 cm. See Note 2.
- Flat-headed nail of approximate diameter 2.3 mm and approximate length 6 cm.
- 100 g mass hanger.
- Stand and boss. The stand should have a height of at least 60 cm. The boss should be able to hold the nail securely.
- Sphere of adhesive putty of mass 12.0 g.
- 180° protractor with 1° divisions.
- Pendulum. See Note 3.

Notes

- 1 A hole of diameter 3.0 mm should be drilled through the rule at the 50 cm mark. A hole of diameter 3.0 mm should be drilled through the rule at the 0.5 cm mark. A string loop of approximate circumference 6 cm should be tied through the hole at the 0.5 cm mark, as shown in Fig. 1.1.

- 2 The paper clips should be linked together to form a chain.
- 3 The pendulum should consist of string of approximate length 30 cm attached to a pendulum bob. The string should have a small loop at the other end, as shown in Fig. 1.2.


- 4 The apparatus should be laid out on the bench. If the apparatus is to be used by another candidate, then it should be restored to its original state. The adhesive putty should be returned to a spherical shape.

Materials and apparatus for Question 2 (per set of apparatus unless otherwise specified)

- M6 × 50 mm set screw (i.e. a bolt threaded up to the head) with a hex head, e.g. RS Components stock number 527-476.
- Three M6 nuts, e.g. RS Components stock number 525-919.
- M6 washer with outside diameter 40 mm and hole diameter 6.4 mm, e.g. RS Components stock number 666-7763.
- M6 washer with outside diameter 25 mm and hole diameter 6.4 mm, e.g. RS Components stock number 666-7766.
- Two 10 mm spanners. If necessary these can be shared between, at most, three candidates.
- Two 100 g slotted masses.
- 30 cm ruler with a millimetre scale.
- 180° protractor with 1° divisions.
- Stop-watch reading to 0.1 s or better.
- Flat board, e.g. MDF, with approximate dimensions 30 cm × 30 cm × 0.5 cm.
- Wooden block with approximate dimensions 6 cm × 6 cm × 4 cm.

Notes

- 1 Assemble the screw, washers and nuts as shown in Fig. 2.1. The nuts should be tightened securely.

- 2 The apparatus should be laid out on the bench. If the apparatus is to be used by another candidate, then it should be restored to its original state. The screw, washers and nuts should be returned to their original arrangement as shown in Fig. 2.1.
